PRESENTATION ON THE REVIEW OF THE WASTE & ENVIRONMENT LEVY

On the 17 January 2012 the Hon Robyn Parker MP, Minister for the Environment announced that the Waste & Environment Levy will be reviewed, with submissions closing on 13 April 2012.

During this briefing OEH and KPMG (who will be leading the review) will brief Members on the specific areas that the Government is seeking to address namely:

- The impact of the waste levy on the recycling industry;
- The impact of the waste levy on households;
- Funding arrangements to facilitate greater investment in infrastructure with local councils & industry;
- The impact on illegal dumping, including the proper disposal of asbestos.

By attending, Members will have an opportunity to better understand the objectives of this review & to ask relevant questions so that suitable submissions can be lodged by WCRA and/or the Members directly.
