### **Lodging Nominations**

Nominations open on 21/05/2025 and must reach the Returning Officer, Benjamin Murray **not later than** 12:00 Noon Australian Eastern Standard Time (AEST) **on** 11/06/2025.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules below prior to lodging nominations.

#### Rule 23 provides that:

No person shall be eligible to be a member of the Executive unless the person is a member of the Association or a Nominated Representative duly appointed in accordance with rule 8.

#### Rule 24(b) states that:

A person standing for an office in the Association must be a Nominated Representative of a financial Ordinary Member and be nominated and seconded by two other financial members of the Association.

Nominations must be lodged via the following method(s):

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to <a href="mailto:lEBnominations@aec.gov.au">lEBnominations@aec.gov.au</a>. The subject line of your email should include the reference "E2025/42 – Stage 1 – WCRANSW - Your Name".

#### PLEASE NOTE:

- 1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
- 2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
