By Hand: Submit a completed nomination form to the Returning Officer in-person at a meeting of the Executive on 06/08/2025.

Voting Period

The opening and closing time of the attendance ballot will be confirmed at the meeting.

In accordance with Rule 24(j) of the organisation, if the AEC receives a request for absent vote, a postal ballot is required. As such, a postal ballot (if required) will open on 13/08/2025 and close at 10:00am Australian Eastern Standard Time (AEST) on 10/09/2025. A postal vote pack will be mailed to eligible voters on 13/08/2025.
